EXPLANATORY NOTES

- (1) One set of forms is to be completed for the deviation application from the authorised design and specification or installation / modification method or programme of each amusement ride. This form is to be submitted by the holder of the installation / modification permit of the amusement ride.
- (2) Submission is to be done via the BCA feedback form (<https://www2.bca.gov.sg/feedback/>).
- (3) A deviation, in relation to an amusement ride, means any change in any material way from the authorised design and specifications or the authorised installation/modification method and programme of the amusement ride, and consists of a change in any of the following aspects of the amusement ride:
 - (i) Structural and mechanical:
 - (a) Structural components (including material specification changes).
 - (b) Loading (for example, a change in the seating arrangements).
 - (c) Range (for example, the height or distance travelled by the amusement ride).
 - (d) Control mechanisms (for example, brakes, shock absorbers, speed limiters, or position sensors).
 - (e) Drive and brake mechanisms.
 - (f) Speed or operating cycle.
 - (g) Passenger harness, protection system and safety envelope.
 - (h) Any safety-critical component, device or system.
 - (ii) Processes:
 - (a) Fabrication method.
 - (b) Joining method and position (including welding, bolting, riveting and any other method).
 - (c) Testing procedure.
 - (iii) Electrical and software:
 - (a) Generator, AC/DC supply, earthing, transformer, cables and conductors and motors.
 - (b) Software or programmed logic.
