If you are a SME owning or leasing office, retail, restaurant and supermarket premises within a building, you can sign up for a **free** basic assessment under the Building and Construction Authority (BCA) Pilot Free Green Mark (GM) User-Centric Feasibility Assessment programme to find out how green your premise is.

From 15 September 2017, BCA will be offering 50 free basic assessments on a first-come first-served basis. All assessments will be completed by 31 August 2018.

1. CHECK YOUR ELIGIBILITY

- Own/lease an existing commercial premise within a building, with a lease period of at least two years
- Submit 6 months of electricity bills
- First time participating in a Green Mark programme
- Applicant to evaluate recommendations from the feasibility study and develop a plan to meet Green Mark Ready

BCA interns will conduct the assessment under the supervision of BCA officers
