

## BCA Green Mark Decal

### Request form for showflats for local Residential Projects

(Please use one form for each building/ project)

**Guide note:**

Developer for Green Mark Residential project (projects which has attained Green Mark Award) may request for one (1) complimentary Green Mark Decal for display in the showflat on condition that the Decal is affixed in a prominent location, such as Main entry to the showroom or Reception etc. **If more Decal is required, please indicate below and locations where these will be affixed.**

The Decal is to be displayed in the showroom of the Green Mark certified project and should not be used for other purpose or location. As such, the Decal shall be displayed only for the period when the showroom is serving its purpose. Photos showing the affixed Decal in the showroom setting to be sent to BCA within 1 week upon receiving the Decal.

BCA reserves the right to withdraw the approval given for the display of the Decal, without assigning any reason, provided that BCA shall exercise this right reasonably.

The project may request for the official Green Mark Decal when the project attained Temporary Occupation Permit.

**Procedure for submitting a request:**

1. Use one (1) request form for each project.
