# ANNUAL MANDATORY SUBMISSION OF BUILDING INFORMATION AND ENERGY CONSUMPTION DATA 2020

1. From 1 July 2013, building owners are required to submit building information and energy consumption data relating to their buildings to the Building and Construction Authority ("**BCA**") annually. This requirement comes under "Section 22FJ – Power to Obtain Energy Consumption and other Information" of the Building Control Act (Chapter 29). A copy of Section 22FJ is provided in Annex 1 below.

2. BCA will be using the data to monitor energy efficiency of buildings in Singapore and formulate the national energy benchmark. The benchmarking results will be made available publicly through BCA Building Energy Benchmarking Report (BEBR)<sup>1</sup> annually, so that building owners can pro-actively improve their buildings' energy performance. For greater information transparency, voluntary disclosed data<sup>2</sup> on energy performance buildings are made publicly available at BCA's website and Singapore's open data portal. In 2018, building owners of 80% commercial buildings and healthcare facilities, and 75% of educational institutions have volunteered to disclose their buildings' data.

3. This year, the submission opening date will start from 17 August 2020<sup>3</sup>.

# (A) For Newly Targeted Buildings - What and How to Submit

4. For newly targeted buildings, BCA has served a written notice to building owners to inform them to complete the submission within a 3-month period. The notice includes the unique system generated login ID and password to facilitate the first-time account registration of the building owners. With the registration completed, building owners can proceed to submit their building information through Building Energy Submission System (BESS) using the CorpPass or SingPass during the submission period annually.

Building owners of newly targeted buildings can also set up their first time account registration during this period. As 15 August is a weekend, the submission opening date will be on the following Monday, 17 August.





5. For the first year's submission, building owners will need to provide all the necessary information. For subsequent annual submissions, building owners are only required to update with latest data.

- 6. The following building information are required to be submitted by building owners:
  - 1) Ownership and Activity Type (Ownership, occupancy type, activity type, etc.)
  - 2) Building Data (Gross floor area, air-conditioning floor area, renovation/ retrofitting works, etc.)
  - 3) Service Information (Lifts, ACMV, lightings and hot water systems)
  - 4) Energy Consumption (Electricity, diesel, natural gas, town gas, etc.)

## (B) For Existing Buildings – Recent Changes

## **Revised Login Mode**

8. For existing buildings, existing registered users using BESSID (email address) can no longer access BESS portal from 2018 onwards. Since the introduction of CorpPass login for Government digital services in 2018, businesses/companies (UEN-registered entities) are required to login BESS portal using their CorpPass accounts, whilst individual building owners can continue to access using SingPass.

9. As the past system mode of login through BESSID has been disabled, existing registered users using BESSID for login will have to update the system on their login mode to CorpPass or SingPass through the "BESS Account Conversion" function. (More details can be found in pages 14 - 15 of user submission manual). Upon the successful update, registered users will then be able to proceed with the data submission via BESS using the updated login mode (CorpPass or SingPass).

## Publication of Building Energy Performance Data in 2021

10. In order to generate self-driven demand for Green Buildings, a phased approach in publication of building energy performance was rolled out. The three phases, starting from mandatory submission of building energy data and voluntary disclosure of the collected data in 2013. In 2020, BCA is introducing the publication of building energy performance data for all buildings, to facilitate benchmarking and spur building owners to undertake retrofitting measures and improve the energy efficiency of their buildings. The first publication of the building energy performance data for all building energy performance data for all buildings will be based on the data submitted under the annual mandatory submission in 2020.

## Penalty for Non-Compliance

11. The Annual Mandatory Submission of Building Information and Energy Consumption Data is a national initiative that requires building owners to provide the necessary information and in conduct under **Section 22FJ – Power to Obtain Energy Consumption and Other Information under the Environmental Sustainability Measures for Existing Buildings** of the Act. A building owner that fails to comply with Section 22FJ shall be guilty of an offence and shall be liable on conviction to a fine not exceeding \$10,000.





# MINIMUM ENVIRONMENTAL SUSTAINABILITY STANDARD (GREEN MARK STANDARD) FOR EXISTING BUILDINGS AND MANDATORY PERIODIC AUDIT OF OPERATING SYSTEM EFFICIENCY

12. Besides the Annual Mandatory Submission of Building Information and Energy Consumption Data, BCA has also implemented two other regulatory measures targeting existing buildings on 2 January 2014.

13. The two regulatory measures are i) the establishing of prescribed minimum green mark standards; and ii) the conducting of periodic audits of the Operating System Efficiency (OSE). Building owners will receive written notices from BCA, should their buildings meet the requirements to comply with the measures. ## Annex 1

## (Section 22FJ of the Act)

#### Power to obtain energy consumption and other information

**22FJ.**—(1) For the purpose of monitoring the energy efficiency and environmental sustainability of any building, the Commissioner of Building Control may do all or any of the following:

(a) by a notice in writing to the owner of the building require the owner to furnish to him all or any of the following information in respect of the building:

(i) the electricity consumption by users of the building as a whole or any part of the building or by different users in the building;

(ii) the consumption of other types of energy by users of the building as a whole or any part of the building or by different users in the building;

(iii) the consumption of chilled water supplied to the cooling system of the building;

(iv) such other information relating to the building, the users of the building and their energy usage as the Commissioner of Building Control may specify in the notice;

(*b*) by a notice in writing to a supplier of electricity, gas or any other type of energy (referred to in this section as an energy supplier), require the energy supplier to furnish to the Commissioner of Building Control information in the possession of the energy supplier relating to the energy consumption of any building or buildings specified in the notice;

(c) by a notice in writing to a supplier of any cooling system to buildings, require that person to furnish to the Commissioner of Building Control information specified in the notice relating to the supply of cooling systems by that person to any building or buildings.

(2) The person to whom a notice is directed under 10 subsection (1) shall provide the data required in the form and manner and within the time specified in the notice.

(3) Any person who, without reasonable excuse, fails to comply with subsection (2) shall be guilty of an offence and shall be liable on conviction to a fine not exceeding \$10,000.
