## Safe Management Measures for Condominiums in The Transition Stage [From 22 November 2021]

The Multi-Ministry Taskforce had announced on 20 November 2021 that we are moving into The Transition Stage from 22 November 2021.

2 Management Corporations (MCSTs) should note the following revised safe management measures (SMMs) and put them in place to ensure compliance.

Solemnis ations and wedding reception s	<ul> <li>Solemnisations may take place at home i.e. place of residence of up to 10 attendees</li> <li>Wedding receptions are not allowed at home i.e. place of residence</li> <li>Solemnisations and wedding receptions may take place at common areas i.e. not in a place of residence</li> <li>Zones of up to 100 attendees</li> <li>At least 2m separation between each zone</li> <li>Unmasking allowed for up to 10 persons engaged in public speaking at any time, so long as speaker maintains a safe distance of at least 2m from audience whilst speaking unmasked.</li> </ul>	<ul> <li>Wedding couples will be allowed to unmask and dance through the wedding reception or solemnisation, while maintaining a 2m safe distance of 2m from the other attendees except for the wedding party</li> <li>Up to 10 individuals from the wedding party will be allowed to sing and unmask at wedding receptions or solemnisations at common areas while maintaining a safe distance of 2m from the other attendees</li> <li>[No Change]</li> <li>Solemnisations may take place at home i.e. place of residence of up to 10 attendees or up to 5 visitors (whichever is higher)</li> <li>Wedding receptions are not allowed at home i.e. place of residence</li> <li>Solemnisations and wedding receptions may take place at common areas i.e. not in a place of residence</li> <li>Zones of up to 100 attendees</li> <li>At least 2m separation between each zone</li> <li>For more information on the SMMs for solemnisations and wedding receptions, please refer to https://www.gobusiness.gov.sg/covid-19-fags/for-sector-specific-queries/marriage-solemnizations-and-receptions</li> </ul>
