The Superintending Officer insofar as it may affect the execution or completion of the Works shall then explain and adjust it and may issue to the Contractor an instruction so as to resolve the ambiguity, discrepancy, conflict, inconsistency or omission. The provision of the geotechnical information by the Employer shall not relieve the Contractor from the responsibility of carrying out his own investigation and/or search for existing and other additional geotechnical information relevant to the Site.</p>	<p>Clause 5.1 Inspection of Site and Geotechnical Information</p> <p>The Contractor shall be deemed to have inspected and examined the Site and its surroundings and to have satisfied himself before submitting the Tender as to the nature of the ground and sub soil and the form and nature of the Site. <b>The Employer shall upon request, provide any</b> Geotechnical information obtained from site investigation, reports, publications and/or journals concerning the site, <b>if available, save that the Employer need not provide such Geotechnical information that it deems to be confidential or sensitive.</b> The provision of the geotechnical information by the Employer shall not relieve the Contractor from the responsibility of carrying out his own investigation and/or search for existing and other additional geotechnical information relevant to the Site.</p>
